Part A—REASON FOR APPEAL

I am requesting an early transfer to the RRc unit in Council Bluffs, IA., that would extend my stay there beyond the typical 180 days. I am not however, requesting an early release date from prison, just an early transfer. My release date without 6 months halfway house is February, 2009.

My oldest daughter, Jayci, age 9, was diagnosed with Cerebral Neuroblastoma in 2001. After years of surgeries, treatments, chemo and even clinical studies, her cancer has continued to grow in her brain and has spread to her spine and is terminal. When a child loses an arm or a leg in an accident, it's a serious situation but it can be dealt with in the years to follow and that child will still have the opportunity to grow up and lead a normal life. When a child is dying of terminal brain cancer, it's an extraordinary situation that can't be dealt with in the years to follow. This child isn't given years to struggle and get through, they've already had years of struggle and are at the end of their life. A child dying of cancer has already seen more than most of us ever will, but they will never see what it's like to earn an income or to see what it'd be like to have children of their own. A child with pneumonia or diabetes is a serious situation but there are cures and medications to help them, but a child that has terminal cancer has already been through all of the surgeries,

In the Regional Administrative Remedy Appeal Part B - Response they ask that I continue working with my Unit Team concerning future escorted trips. I have been told by Ms. Allen from my Unit Team that I will get no more trips to see my daughter not even when she dies.

I am requesting an early transfer date to the halfway house (RRC Unit) so I can be with my daughter, Jayci. My release to RRC will be late Aug. or early Sept.. In my world it's less than 10 months that we're discussing, but these 10 months in her world will make a huge difference in the remainder of her life.

This is all about 10 months and the life of a dying child.



Part B - Response

This is in response to your Central Office Administrative Remedy Appeal in which you request an immediate placement in a Residential Reentry Center (RRC) due to your daughter's medical condition. You claim your specific circumstances warrant extraordinary circumstances.

Our review reveals the Warden and the Regional Director accurately addressed the issues raised. The issue pertaining to Residential Reentry Center placement is within the authority of the Warden and the Regional Director, as set forth in Program Statement 7310.04, Community Corrections Center (CCC) Utilization and Transfer Procedure. Recommending a Residential Reentry Center placement and the length involves the review of several factors including the inmate's current offense, institutional adjustment, medical and mental health concerns, as well as history of escapes and violence.

While we empathize with your family situation, a final and specific release preparation plan, including a decision as to RRC referral is normally established at approximately 11 to 13 months before an inmate's projected release date. Staff will review your pre-release needs as you get closer to your release date and will make the appropriate recommendation at that time. We therefore concur with the responses provided. Accordingly, your appeal is denied.
